



Information brochure Group reservations

N.B. As long as restrictive Corona measures are in force, different arrangements and rates apply for Group reservations. These are shown below.

Private Dining Room

Our Private dining room on the first floor is currently also in use as À-la-carte restaurant, due to the Corona restrictions.

Exclusive use of the Private dining room for a private dinner and/or meeting is still possible, but only after careful consultation and with precise agreements about the number of people, table layout and minimum spending.

The Corona rules mean the following:

- A maximum of *4 people* may sit at 1 table at a normal distance. This restriction does not apply to households of more than 4 people.
- With more than 4 people at 1 table, a distance of 1.5 meters between the table companions must be maintained. *This restriction also does not apply to households of more than 4 people.*
- A distance of 1.5 meters is maintained between the dining tables.

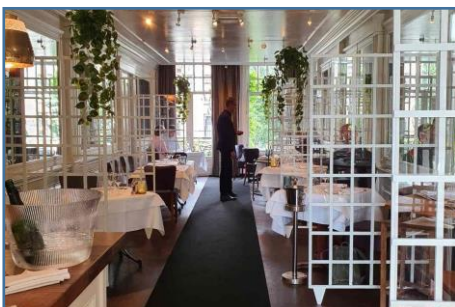
The table arrangement therefore depends on the composition of the group. *For example*, if it concerns a group that does not consist entirely of households, we can place **a maximum of 20 people** by setting up **5 tables of 4 people**. If the group consists of one or more households of more than 4 people (eg at family dinners), more people can be placed at fewer tables. So there are several options.

The number of people and table arrangement are precisely agreed upon at the time of reservation.

The basic price for the room rental is € 300 per half day.

In addition, a minimum spending can be requested per booking.

The rental of *audio-visual equipment* is €85.





Restaurant + Private Dining Room (buy-out)

Would you like to buy out our entire restaurant (lower and upper floor, possibly garden) exclusively for a festive private dinner? And is your group larger than 20 people? Then there is the possibility to place a maximum of 22 people in the restaurant downstairs and a maximum of 20 people in the Private dining room upstairs.

The upstairs room can also serve as a reception area with an aperitif and cocktails, followed by the dinner downstairs in the restaurant for up to 22 people.

The costs for the buyout, also minimum spending, are:

Tuesday, Wednesday, Sunday (5:30 pm – 11 pm):
€ 3800

Thursday, Friday and Saturday (5:30 pm - midnight):
€ 5000

The specific menu, wines, snacks and drinks, as well as the table layout *by appointment*. In principle, the same rules apply to the exact number of people and the layout of the tables as mentioned above for the Private dining room.





Menu

For lunch or dinner, you can choose from a 3-, 4- or 5-course menu, consisting of a starter, main and dessert, which can be expanded with an intermediate dish and/or cheese platter. For the starter and main course there is always a choice between fish, meat or vegetarian.

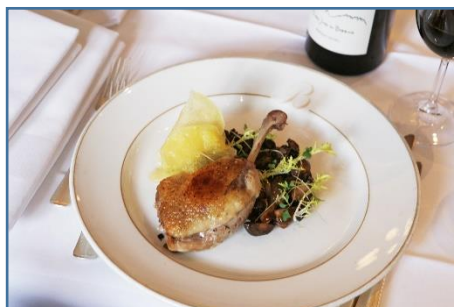
The standard wine package for these menus consists of 3 glasses of house wine. Half a bottle of mineral water pp is included in the menu price. These are the following:

- 3-courses € 62 p.p., incl. water and wine package
- 4-courses € 72 p.p., incl. water and wine package
- 5-courses € 82 p.p., incl. water and wine package

The Menu will be sent on request.

Wines

In consultation, an adapted wine arrangement with à la carte wines can be agreed.





Booking conditions and cancellation rules

Option /Final reservation

Those considering making a group reservation can get an option on the intended reservation date and time for a short period (between 1 and 14 days - depending on the reservation date). The option is converted into a (final) reservation after receipt of:

- (a) written confirmation of the desired reservation; and
- (b) the deposit.

Without this confirmation and deposit, the option will automatically expire after the granted option period.

Deposit

A deposit of € 300 (room rent) is due for a definitive reservation. Brasserie van Baerle may require a higher or lower down payment in some cases. The deposit will be settled with the final settlement or – in case of cancellation – with the amount owed according to the cancellation rules.

How many persons?

When booking, the expected number of people is stated. This number can be changed – only in writing – up to 24 hours before the reservation time. The number of persons known at that time is considered final.

Cancellation Rules

In addition to the *Uniforme Voorwaarden Horeca* (standard conditions) , the following cancellation rules apply to a group reservation (unless otherwise specified in the reservation agreements):

- In case of cancellation from 1 month to 2 weeks (=14 days) before the reserved time, € 500 is due.
- in case of cancellation from 2 weeks (14 days) to 1 day (24 hours) before the reserved time, €1000 is due.
- in case of cancellation 24 hours or less before the reserved time, as well as in case of no show, € 1500 is due.

Payment settlement

At the final settlement, the amount of the total expenditure or the agreed buy-out amount (possibly increased by additional expenditures above the agreed buy-out amount) and any agreed additional costs (eg audiovisual equipment) will be charged. The deposit will be settled with this.

Payment can be made in cash, by pin or by credit card.

When paying on account, the invoice is increased by € 19.50 for administration costs. The bill must be paid within 10 days. If the payment term is exceeded, collection costs will be charged.
